The recent events surrounding Ukraine and Russia have created serious challenges for many, including for our ministry, and we are trusting in Jesus Christ to meet our needs. The main thing for our ministries in Russia is to be able to keep and pay our employees,


because there is a lot of work to do. Pray that our regular wire transfers will soon be allowed to be sent to our ministries in Russia again. Right now the US government sanctions are preventing it. (Please see the section at the end of our letter called "Sanctions" for more details.) However, it is exciting to see God's blessing and provision in other ways... for a year now we've prayed for the sale of the Nikulino property, and in God's perfect plan and timing, on April 29th the sale should be completed and the funds will be available for ministry needs in Russia!

Ministry to Ukrainian refugees - So far we have sent \$39,000 to help refugees at 3 locations, and are sending more funding each week or two. Besides providing humanitarian aid, our partner churches and missionaries are sharing the Gospel, praying with people, and even helping to stop human trafficking.



**Poland** – "I thank each person that supports us so we can support people in Ukraine. Every day, we have cars and vans going into Ukraine with aid. We were able to send a few containers with aid as well. We are providing them with lifesaving supplies such as food and hygiene kits, medicines, first aid kits, tourniquets, blankets. We also pray for them

and tell them about peace that Jesus brings into our lives. Humanitarian needs are multiplying by the hour as fighting intensifies in Ukraine. Right now we are planning to buy more first aid kits, bandages, medicine, food, condensed milk, dry broths,

**Prison ministry**. At the end of March, all COVID restrictions on visits to Russian prisons were lifted, and ministry began actively among the convicts again. Thanks be to God. But in early April, the health of Vyacheslav Kozlov suddenly deteriorated. He is a very effective prison minister in the Komi Republic. Brother Vyacheslav has been visiting



prisons, often quite remote from each other, for more than 15 years, visiting prisoners' children in shelters and feeding and preaching among the homeless. Although he is doing better, <u>please pray for his full recovery</u>. With our limited funds, we were still able to send him our prison magazines and equip Vyacheslav's assistants with everything necessary for holding festive Easter meetings in prisons.

## **RCR Recording Studio Ministry**

Nothing changes for our viewers abroad, but Facebook and Instagram have already been blocked in Russia, and YouTube might be, but this does not mean that our ministry is ending. The RCR studio is mastering Russian video resources (RuTube, VK.Video, Telegram) to give Russian residents access to our programs.

## **Pirkko Home Liberation Center Ministry**

Despite the current difficulties, God's work in the Pirkko Homes is being accomplished. Our leaders, together with local churches, carry out spiritual work to free the residents from addictions and they work physically to provide food. Because of your help, needs were provided for in the centers of Zheleznogorsk, Orel, Dyatkovo, Kokino and Rumyantsevo (beds & bedding, a stove, a washing machine, freezers). Thank you very much! The feeding of the homeless and the distribution of fresh bread & Bibles by the centers in Zheleznogorsk and Rumyantsevo is bearing fruit - due to this ministry people come to the Pirkko Homes and to the local churches. Praise God!



#### **Sanctions**

President Biden has imposed certain sanctions on Russia in response to its invasion of Ukraine. We are listing the rules so you can read them yourselves. Executive Order 14068 (section 1 a iv) prohibits the export of U.S. dollars to Russia or any person located in the Russian Federation. This, together with Executive Order 14024, on transactions involving certain foreign financial institutions, explains why our usual transfers through our banks are blocked. Further details are included in General License No. 18 (from the Department of the Treasury) that authorizes personal remittances from a U.S. person to an individual located in the Russian Federation, excluding charitable donations to an entity. There is a possibility of obtaining a special license to continue our work as before, and we have contacted the Office of Foreign Asset Control, but have had no response yet.

Together, all these rules seem to indicate that RCR-US cannot currently send donations to RCR-RU in Russia, but so far you can make <u>personal</u> gifts to the Russian staff (that are not tax-deductible). To do this, you may write a check to <u>Alexey Tuchin</u> (RCR Vice Chairman) and send it to 9707 NE 119<sup>th</sup> Street, Vancouver, WA 98662, and include your phone number, and he will send your personal gifts to staff members in Russia.
